I will comply with New York State Law that requires sales tax to be collected.

I shall and will hold harmless the Copiague Chamber of Commerce, LI Family Fun Festival, Inc. and Nightingale & Nightingale, Inc. and its members from and against any and all claims, liabilities, demands, expenses, fees, penalties, suits, proceedings, actions and causes of action of any and every kind and nature arising from or out of, or in any connected way with vendor use, occupancy or activities in or related to the LI Family Festival taking place Sept. 16-18. **Vendors will be personally liable to other participating vendors and members of the public for their own acts and are responsible for obtaining their own insurance.**

I understand that neither the Copiague Chamber of Commerce, LI Family Fun Festival, Inc. and Nightingale & Nightingale, Inc. nor its members will be held responsible for loss and/or damage to vendor's personal property caused by any reason and I will not assert any such claim against them.
